Entry Information

1. No entry will be accepted unless all particulars called for on the entry form are completed in full. Handlers or agents please note the full name and address of all owners must be filled in.
2. Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees.
3. There is no refund for duplicate cheques. Every effort will be made to find all duplicate entries. However; if the entry has been processed and appears in the official catalogue, no refund will be made.
4. Alterations, substitutions or cancellations of any entry after the closing date is prohibited. Moving Class Dogs to Specials or unconfirmed Specials back to the classes is permitted. An error in the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show. Only dogs that are already registered in the Canadian Kennel Club Stud Book, or are eligible for such registration, can be entered. The committee reserves the right to refuse any entry subject to CKC Rules.
5. Judging schedules will be e-mailed as soon as possible after the entries close.

6. Tendering of NSF cheques in payment of fees shall be considered non-payment of fees and is punishable by disciplinary action. ***Any NSF cheques will be subject to a \$35 service charge.***

General Information

1. The Show Superintendent will be in full charge of the show, which will be governed by CKC Rules.
2. The Staffordshire Bull Terrier Club of Canada will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
3. If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show, no refund of Entry fees will be made.
4. Dogs should arrive in adequate time for judging (allowing for absentees) and will be excused each show when not required for further judging. It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging. Waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds conflict.
5. Judging will commence at 10 a.m. each day.
6. **SHOW PRECINCTS:** The show precincts shall include of all areas set out for rings, all shelters or facilities set aside for show officials, judges, exhibitors and handlers.
7. All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events, and do not have a CKC registration number, will require an Event Registration Number (ERN). The ERN number MUST be applied for within 30 days of the first day of entering a CKC event. The fee is \$64.00 per dog, plus applicable taxes. Event Registration Number (ERN).
Effective January 1, 2011: For the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.

Non-Member Participation Fee

A Temporary Competition Number (TCN) allows dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN). A TCN must be obtained before submitting an entry for an event. The same TCN must be used for all event entries for a dog until the dog is permanently registered or has an ERN. TCNs can be obtained through your CKC member portal or by contacting the CKC.

Note: There is no CKC fee to obtain a TCN. However, a TCN 'listing' fee is required each time a dog with only a TCN is entered in an event. Temporary Competition Number (TCN) \$55.00, plus applicable taxes.

NATIONAL SPECIALTY JUDGE - KIM REEDER



I have been involved with the dog world since the age of nine. Participating in all aspects of the dog world including administration of the foundation breed club of Australia the Staffordshire Bull Terrier Society of NSW Inc, in various positions over the decades including Secretary, show management, protection of the breed with input to government legislation. Breed Assessor, State Government. Event management of events for RAS now know Dogs NSW served on PR Committee of Dogs NSW. Mentoring Stafford folk in all aspects including handling, animal husbandry and education of aspirant judges.

Our family The Reeders of Gamester Staffordshire Bull Terriers purchased their first Stafford in 1967 registering the Gamester Prefix with the Royal Agricultural Society of NSW in 1968 breeding their first litter in that year. Our first show dog Australian Champion Torumba Blue Samantha when the Staffordshire Bull Terrier was a minority breed in Australia. Sam helped set the show scene for the Staffordshire Bull Terrier in Australia.

We registered The Reeders as a hobby of pure bred dogs' exhibition and breeding as it was a family activity and interest for all members of our family as they were all involved in some aspect or another.

Mentored by my mother the matriarch of the breed in Australia Yvonne Reeder and as a co-owner breeder, on her passing our breeding and name lives on with the continuous co-ownership of our name Gamester Staffords The Reeders along with my sister Kerrie Reeder.(also an international judge)

I, along with my family have bred, imported and exported, exhibited, handled top award winning Staffordshire Bull Terriers continuously since 1968. I have co-bred and co-owned and handled some of Australia's and NZ's UK and top award-winning Staffordshire Bull Terriers.

Importing the very best bloodlines from NZ UK, Wales, South Africa and USA to set the groundwork for the Staffordshire Bull Terrier in Australia and NZ. Not least pioneering frozen semen to Australia with many other milestones for our beloved breed. Owning breeding and importing and handling every colour without prejudice.

I have been fortunate to have handled top quality Staffordshire Bull Terriers to top awards in the following countries: England, Sweden, Canada, New Zealand, USA, Bermuda, Australia.

REGIONAL SPECIALTY JUDGE – Heather Brennan



Heather Brennan didn't have a dog growing up and has spent her entire adulthood trying to make up for it by spending as much time with dogs as she can. Together with her family, Heather initially bred Siberian Huskies under the Nuthatch prefix. Over the years, they dabbled in Belgian Tervuren and German Wirehaired Pointers, but they fell in love with German Shorthaired Pointers early on and have had them ever since. Nuthatch GSPs have won championship titles in

multiple venues all over the world including Australia, Mexico, Colombia, FCI, the United States and Canada.

Heather has lived in Canada her whole life but loves to travel and explore new destinations. Combining travel with her love of dogs was a natural move. She firmly believes in form follows function and has participated in performance events with all her breeds including recreational mushing, herding, and field tests. As a judge she has been privileged to judge at all breed shows in Australia, Canada and the USA and at several specialties. As a Gundog and Utility (Working Group in North America) specialist she has judged specialties for several breeds as well as group specialties. Highlights include Working Group Dog Club of Alaska, Ottawa Valley All Pointing Breed, Pointer Club of Canada national specialty and the German Shorthaired Pointer Club of America national specialty.

Heather is the author of a number of articles and books on canine conformation, judging, ethics, field events and breed specific activities. She is the show chair for one of Canada's largest indoor dog shows, Aurora and District Kennel Club. She has also held positions on the Board of Directors for all breed and breed specific clubs.

GENERAL INFORMATION

Indignities to a Judge

A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

Attention Foreign Exhibitors

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted.

Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank You.

ELIGIBILITY TO COMPETE:

No person shall enter or exhibit a dog under a judge which that judge has owned, conditioned, trained, (including handling/presentation classes), bred to, sold, handled, held under lease, boarded or held in residency within six (6) months prior to the date of the show at which he officiates as a judge. This rule shall apply regardless of whether the judge benefited in any way from any of the aforementioned activities. It is the responsibility of the owner

CKC Rule 8.2.1

Every dog, including baby puppies, entered in a conformation show must be one of the following:

- (a) registered with the CKC;
- (b) have an Event Registration Number (ERN);
- (c) have a Temporary Competition Number (TCN), and must be eligible for registration with the CKC;
- (d) Listed breeds must have a Miscellaneous Certification Number (MCN).

CKC HEALTH RULES:

8.8.1 No dog may be entered at a show if it has any communicable disease.

8.8.2 Dogs entered in a show must have current immunization status.

8.8.3 No dog may be brought onto the grounds or premises of a show if it:

- (a) is known to have distemper, parvovirus, kennel cough or other communicable disease; or

- (b) has recovered from distemper, parvovirus or other communicable disease within the last 30 days.
- (c) has been housed within 30 days prior to the show, trial or test on premises on which there existed distemper, parvovirus, kennel cough or other communicable disease.

8.8.4 Where it is found that these rules have been contravened, the dog in question shall be removed from the show premises and the exhibitor/handler will be subject to disciplinary action.

Clubs do have the right to remove a dog from the event premises, and the exhibitor may be subject to disciplinary action if it is found that CKC rules have been contravened.

UNSPORTSMANLIKE BEHAVIOUR

- 11.1 It shall be deemed unsportsmanlike conduct if a person, during the running of or in connection with an event, abuses or harasses a judge, show official or any other person present in any capacity at the event.
- 11.2 Any handler who displays unsportsmanlike conduct, or who is seen to kick, strike or otherwise roughly manhandle a dog at any time during the holding of the event, may be expelled from the show by the Conformation Show Committee.
- 11.3 The judges shall also have the authority to expel a handler from a show if they observe unsportsmanlike conduct on the part of the handler, or see the handler kicking, striking or otherwise roughly manhandling a dog while the event is in progress. It will be the duty of the judge to report promptly to the Conformation Show Committee the expulsion of a handler.
- 11.4 The Conformation Show Committee shall investigate, at once, any instance of alleged unsportsmanlike conduct on the part of the handler, or any report that a handler has been observed kicking, striking or otherwise roughly manhandling a dog. If the Conformation Show Committee, after investigation, determines that a handler is in violation of this section, and that the incident, if proven, would constitute conduct prejudicial to the sport or the CKC, it shall exercise its authority in accordance with the Complaints section of these rules.
- 11.5 The Show Superintendent shall submit to the CKC a complete report of any hearing action taken under this section within 14 days.

Exhibitors, handlers, judges and assistants are expected to participate with honesty, fairness and integrity, ever mindful of the practice of “good sportsmanship”, before, during and after this show. Any person engaging in an activity that might be considered malicious, threatening or constitutes bullying, including but not limited to transmission on social media, will be asked to leave this show without compensation and will be banned from any future shows held by this club.

Championship Points

- 15.1.1 A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from zero (0) to five (5)) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

15.1.2 The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

Dogs Competing:	1	2	3-5	6-9	10-12	13 or more
POINTS ALLOCATED*	0	1	2	3	4	5

*Includes the dog awarded WINNERS

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall not be included in the calculation for championship points.

15.1.3 If a dog awarded Winners is also awarded Best of Breed at the show, then all dogs competing in the breed, including Specials Only, shall be included in the total.

15.1.4 If a dog awarded Winners is also awarded Best of Opposite Sex to Best of Breed, then all dogs of the same sex including those competing in Specials Only shall be included in the total.

15.1.5 If a dog awarded Winners is also awarded Best of Winners, then all dogs defeated directly or indirectly in the breed shall be included in the total.

15.1.6 If a dog is awarded Winners only, then all the dogs of the same sex in the class competition shall be included in the total.

15.1.7 The number of championship points to be credited to a dog awarded Winners shall be determined by the highest award earned and calculated as per this section.

Clarification:

Example of directly or indirectly defeating: If the Winners Bitch is awarded Best of Opposite Sex but not Best of Winners, the Best of Winners Dog shall be deemed to have indirectly defeated the Specials bitches and is thus entitled to add them to the number of dogs and bitches defeated.

15.1.8 In addition to championship points allocated at the breed level, a dog awarded Best of Breed that also places in the regular group competition shall be credited with the following additional points provided that a dog was defeated at the group level.

15.1.9 A dog may not be credited with more than five (5) championship points in a single show.

15.1.10 Permission shall be granted a club or clubs to hold shows in such a way that any dog may earn three (3) sets of championship points on the same day, provided that one or more of those sets of points is awarded at a specialty for that breed or group.

15.1.11 A dog awarded Winners that also places Best in Show at an all-breed conformation show shall be credited with five (5) championship points inclusive of any points earned at the breed and group level.

15.1.12 A dog awarded Winners that also placed Reserve Best in Show at an all-breed conformation show shall be credited with four (4) championship points in addition to any points earned at the breed and group level, to the maximum allowed championship points in a single show.

15.1.13 In order for a dog to be recognized as a champion and its owner provided with a championship certificate, the dog must:

- (a) earn at least ten (10) championship points under at least three (3) different judges;
- (b) be registered in the records of the CKC, have an Event Registration Number (ERN) or have a Miscellaneous Certification Number (MCN);
- (c) have earned at least one (1) two (2)-point win either at the breed or group level.

15.1.14 The Board interprets the words "earn at least ten (10) championship points under three (3) different judges" to mean:

- a) At a single breed National Specialty, the male designated Reserve Winners Dog will be awarded three (3) championship points, provided that the number of dogs competing in the regular classes is sufficient for the Winners Dog to have received five (5) points.

- b) At a single breed National Specialty, the female designated Reserve Winners Bitch will be awarded three (3) championship points, provided that the number of dogs competing in the regular classes is sufficient for the Winners Bitch to have received five (5) points.
- (c) Three (3) or more Winners awards at not less than three (3) different shows, under three (3) different judges at the breed level;
- (d) each of the three (3) judge's awards must be one or more championship points won at Winners, Best of Winners, Best of Breed or group placing;
- (e) all points required for championship status may be earned at Winners, Best of Winners, Best of Opposite Sex, Best of Breed or group placing
